Getting the vaccinations recommended by your doctor is an important part of your preventive care. So it's important to know that your vaccination coverage is separated into two parts.

- 1. The vaccine what product you get.
- 2. The administration how you get the vaccine.

Your HealthSpring Rx Medicare (PDP) plan covers many vaccines administered at your doctor's office or pharmacy, including:

- Shingles: Shingrix®
- Tetanus: Adacel, Boostrix, mRESVIA
- RSV: Abrysvo, Arexvy

Your medical insurance covers other vaccines, including:

- Yearly flu
- Pneumonia
- COVID-19
- Hepatitis B



Taking control of your health is important, so give it a shot.

- Talk to your doctor about which vaccines are right for you.

FDA-authorized COVID-19 vaccines will be covered under your medical plan (or Medicare Part B) as a preventive service. You pay nothing for the vaccine, booster shots, or additional doses.
